# MIGRANT CITIZEN'S RIGHTS AND DUTIES FOR ACCESS TO HEALTH



- Any Migrant in Portugal has the right to health and the duty to protect it.
- Migrants who are ill in Portugal have the right to be assisted at the Health Centre or Hospital in their area of residence in an emergency. (Order No. 25360 / 2001, of November 16)
- Assistance cannot be refused on grounds of nationality, lack of economic means, irregular situation or another.

## What to do if there is a refusal to provide HEALTH CARE?

You should go to the Citizen Office Support of the Odemira Health Centre Hospital do Litoral Alentejano (Santiago do Cacém) / José Joaquim Fernandes Hospital (Beja), regarding the medical needs.

## Where you can get the National Health System (SNS) number

The user number can be purchased free of charge:

Odemira Health Centre / Health Extensions; Citizen's Shop, outside the municipality of Odemira.

### What is the user number for?

Access to health care; Obtain diagnostic requests; Obtain prescription and purchase of medications.

## Who can get the user number?

Access to health care; Obtain diagnostic requests; Obtain prescription and purchase of medications.

# What to do in the case of migrants who do not hold a Residence Permit or who are in an irregular situation or without documents?

Request from the Parish Council a certificate of residence as you have been residing in Portugal for more than 90 days (must be accompanied by 2 witnesses);

Identification document: passport or other. Those who do not meet the above requirements will have to pay the fees provided for in the legislation in force, except in the following cases:

Urgent and vital health care; Communicable diseases presenting a danger or threat to public health (tuberculosis, AIDS, others);

Maternal and child health, reproductive health, family planning, voluntary termination of pregnancy, follow-up during pregnancy, childbirth and postpartum, health care for new-borns;

Health care for children up to 12 years of age residing in Portugal;

Vaccines (according to the National Vaccination Plan);

Newly arrived foreigners in a family reunion situation, whenever someone in their household pays social security contributions:

Migrants in situations of social exclusion and economic need, as evidenced by Social Security.

# What health care will you have to pay?

All migrants are subject to the same principles and rules as apply to the general population with regard to the payment and exemption of moderator fees in accordance with the Law (Ordinance No. 20/2014 of 29 January).

Access to National Health System Services by evacuated foreign nationals is covered by international cooperation agreements and conventions concluded between Portugal and the different countries of the member states and Portuguese-speaking countries.
